

# Official 2021 VEHICLE PIT ENTRY POLICY– Grundy County Speedway



Effective May 1, 2021 through December 31, 2021

The Grundy County Agricultural District Fair, Inc. dba Grundy County Speedway hereafter known as GCS.

## Foreword

The primary purpose of Grundy County Speedway is to enhance the sport of automotive racing through, among other things, conducting and sanctioning GCS races. In furthermore of this supervisory and regulatory function, GCS has adapted the safety and completion rules set forth in this book. These rules as amended, supplemented or superseded are effective for the 2021 Grundy County Speedway unless otherwise expressly provided. All GCS members and all teams, race and series sponsors, as well as every other person participating or involved in any way in a GCS sanctioned racing event, shall be bound by these rules, as amended, supplemented or superseded from time to time and shall be responsible for compliance therewith. It is therefore recommended that you read this Rule Book carefully to assure your familiarity with the rules and regulations contained herein.

The rules and regulations that govern the activities of GCS are intended to assist in the orderly conduct of these activities and have been set forth to establish minimum acceptable requirements. No express or implied warranty of safety shall result from publications or compliance with these rules and/or regulations. They are intended as a guide for the conduct of the sport and are in no way a guaranty against injury or death to participants, spectators or others.

## Part 1 - Guest Vehicle Pit Entry

1.1 Vehicle entry to pit area during Grundy County Speedway scheduled race events will be restricted to race teams only and will only be allowed for the following:

- A. Vehicles used for towing race trailers with race car.
  - a. No Vehicle Pit Entry Permit required.
- B. Vehicles displaying an official State Handicapped Placard.
  - a. Vehicle Pit Entry Permit will be required.
  - b. No fee for authorized handicapped vehicles.
  - c. Limited to 1 permit per race team for authorized support of a race team.
- C. All other guest vehicles will be required to purchase an annual Vehicle Pit Entry Permit.
  - a. This permit is exclusive to race teams only and is limited to 1 permit per race team for authorized support of a race team.
  - b. This permit will allow the guest vehicle entry to the pit area only during Grundy County Speedway scheduled race events.
  - c. All other Speedway related events will be at the discretion of event promotor.
  - d. The fee for the annual Guest Vehicle Pit Entry Permit is \$50.00.
  - e. Permits can be purchased at the pit registration building.
  - f. All proceeds from Guest Vehicle Pit Entry Permits will be applied to end of year points fund.
  - g. Vehicle Pit Entry Permits for guests will be limited to a maximum of 50 permits.

1.2 Grundy County Speedway Vehicle Pit Entry Permit must be properly displayed on the driver's side windshield at all times when inside the Speedway pit area.

1.3 Vehicles without properly displayed Vehicle Pit Entry Permit will be subject to towing.

- 1.4 All vehicles must be properly licensed with proof of insurance.
- 1.5 Vehicle must be parked in designated area and not blocking others or roads. Vehicles improperly parked will be subject to towing.
- 1.6 All persons entering the pits are still required to register and purchase a pit pass at the Speedway pit registration building.
- 1.7 Any person entering the pits without a registered pit pass will be considered as trespassing and authorities will be notified.
- 1.8 Permits are not transferable between vehicles. If vehicle is sold or out of service, then remove the entry permit from windshield and turn it into the Fair office for replacement.

## **Part 2 – Police, Emergency and Officials/Employees Vehicle Pit Entry**

- 2.1 The following vehicles will be allowed entry to the pit area.
  - A. Police and Emergency Vehicles.
    - a. No Vehicle Pit Entry Permit required.
  - B. Speedway Officials and Employee Vehicles.
    - a. Vehicle Pit Entry Permit will be required.
  - C. Grundy County Agricultural District Fair Officials.
    - a. No Vehicle Pit Entry Permit will be required.

## **Part 3 - Amendment to Policy**

GCS reserve the right to revise this policy and to issue supplements at any time without prior notice. GCS may promulgate special rules which it/they deem conducive to the well-being of an event.
